SHIPPING RATES: Our shipping charges are based on the weight of the order, where the order is shipping to, and the warehouse the order is shipping from. We charge the posted FedEx Home Delivery and surcharges to ship a package to your home; an imbursement is included in the total shipping cost.

We make every attempt to ship your order the same day when it is placed by 4 pm Monday thru Friday; Express orders need to be received by 1 pm Monday thru Friday. Home Delivery orders deliver to your door Tuesday thru Saturday and Express orders deliver to your door Monday thru Friday. If you are not in a hurry to receive your order, select FedEx SmartPost which delivers through the U.S. Post Office.

We ship from multiple warehouses across the U.S., the truck symbol located by each product indicates the warehouse the product ships from; to reduce your shipping costs, select products from the same warehouse.

We only ship orders to addresses in the U.S.



CUSTOMER CERTIFICATION: The customer certifies they are 21 years of age; a legal resident of the U.S., the products purchased are for personal use in the U.S., and they will not be sold or transported outside the U.S. The customer has checked Local, State, and Federal laws and ordinances prior to ordering and will adhere to them.

QUALIFIED BUYERS: Cheaper Than Dirt! (CTD) sells merchandise only to individuals who can legally purchase and own the products in the particular jurisdiction where they reside. The purchase of products from CTD over the internet, on the telephone, through mail or fax, and in person legally binds the customer and their heirs, transferees, and personal representatives as follows: The customer is a legal, adult, U.S. resident that has checked all local, state and federal laws; they can legally purchase the products and will not resell or transport any of the products outside the U.S. By offering products for sale, CTD does not represent or warrant that any specific customer may legally purchase, own, or possess the products ordered.

The customer agrees they shall use the purchased products in a safe and legal manner consistent with all applicable laws, recognized safety rules, good common sense, and will keep it out of the hands of minors or unauthorized individuals. Further more, the customer will assume responsibility and all risks related to and/or arising from ownership and use of the products and agrees CTD is not responsible and will hold CTD harmless for use of any and all claims brought by any person or entity against CTD related to and/or arising from the customers' ownership and/or use of the products.

PRODUCT RESTRICTIONS: Some of the products sold by Cheaper Than Dirt! may be restricted by local city, state, and federal laws; please check laws prior to ordering. Our website, www.CheaperThanDirt.com has a listing of product restrictions. Regardless of the customers' profession, restricted products will not be shipped to restricted areas.

Ammunition purchases require a copy of the customers' drivers license or a verbal affidavit confirming that they are over the age of 21 and there are no laws prohibiting them from owning ammunition. Illinois residents are required to provide a copy of the customers' F.O.I.D. card. Ammunition is non-returnable. The handling of ammunition may cause exposure to lead.

Firearm purchases must ship to a Federal Firearms Licensed (FFL) Dealer and the customer must pass a NICS check to receive the firearm from the FFL dealer. Firearms are non-returnable and non-refundable regardless if the customer takes possession. Discharging and cleaning firearms may cause exposure to lead.

All of our products are intended for personal, adult use only within the U.S.

In compliance with Federal Regulations we cannot ship products that may be used for defense or concealment and products that are similar to any issued by the military; for this reason, we do not ship to APO and FPO addresses.

CREDIT CARDS: We accept U.S., American Express, MasterCard, Visa, and Discover Card. The card will not be charged until the items are shipped. On the back of the credit card is the phone number of the bank that issued the credit card, please include this phone number and CID# with the credit card order. We may contact your credit card company to check if the ship-to address you specified has been listed with them. We may also ask you to verify any different ship-to address in writing. This is done for your protection to prevent credit card fraud. We will not accept credit cards issued outside the U.S.

NOTICE FOR ARC ENTRIES: When you provide a check as payment, you authorize us either to use information from your check to make a one-time electronic fund transfer (EFT) or bank draft from your account or to process the payment as a check transaction. When we use information from your check to make an EFT, funds may be withdrawn from your account as soon as the same day we receive your payment. If we make an EFT or bank draft, you will not receive your check back from your financial institution. If your payment is returned due to insufficient or uncollected funds, you authorize us to collect a service charge via a one-time EFT or bank draft from your account in accordance with state law, as follows: (i) \$20 in CO, CT, DC, IN, NM, NY, and UT; (ii) \$25 in AZ, AR, CA, IL, KY, ME, MA, MI, MO, NE, NV, NH, NJ, NC, ND, OK, OR, PA, RI, VT, WA, WI and WV; (iii) \$30 in AL, AK, HI, IA, KS, MN, MT, SC, SD, TN, TX and WY; (iv) \$35 in MD and VA; (v) \$40 in DE and MS; (vi) FL = \$25 if check is < \$50, \$30 if check is < \$300 but > \$50, \$40 if check is > \$300, or 5% of face amount of the check, whichever is greater; (vii) GA = \$30 or 5% of face amount of the check, whichever is greater; (viii) ID = face amount of check or \$20, whichever is less; (ix) LA = 5% of check or \$25, whichever is greater; (x) OH = \$30 or 10% of face amount of check, whichever is greater. If you prefer not to have your check converted to an electronic debit you may use other methods of payment listed on the order form.

RETURN POLICY:

No Hassle Return Policy: If you are not satisfied with your purchase, you may return it within 90 days of the invoice date; except for Firearms, Ammunition, and Food. Products returned not in the original packaging may be subject to a restocking fee. Products showing excessive usage will not be refunded. Firearms, Ammunition, and Food are not returnable or refundable; all sales are final.
